Karen will demonstrate how to have clean colors, and how to make objects ghost-like. This will be a limited color watercolor. Several tricks make this an easy process, but when you see the finished painting, you won't think it's simple. Watch this Zoom demonstration to learn the secrets to a transparent watercolor with good design..

Karen loves teaching workshops monthly all over the United States. Recently, she has grown to love outdoor painting (plein air), even though it is a difficult

process. "I finally know what it means to "be in the moment and not care about the outcome of the painting, when I plein air paint. I remember smells, people, conversations, temperatures, everything.... Just by looking at the painting that I did outdoors."

Karen recently obtained signature status in the American Watercolor Society, based in NY. It was her lifelong dream to get that signature. From the President

Hello Artist Friends and Members!

As you read this newsletter we are beginning the new year with the hope that we can have more in-person gatherings. As you may know our members meetings are now at the Hopkins Center for the Arts, 1111 Mainstreet in downtown Hopkins. Our January meeting is zoom only and our



February demo will be in person with Suzanne Schaff. We will continue to have the zoom option to attend as well.

I hope you are planning to enter the Spring Juried Exhibition. Entries will be accepted from February 1 through 7, so plan accordingly. The juror is Richard Kochenash and the show takes place at the Minnetonka Center for the Arts.

We also look forward to the possibility of a Members Day event this year! Information will be sent as plans are firmed up. I was at dinner with friends and the topic of "lost arts" came up. A few things we cited were- cursive writing no longer being taught at school, the ability to read a clock with hands, and how to use a turntable or a rotary phone. I'm sure there will be a time in the future when these terms will disappear from our vocabulary and way of life. What we are losing is our personal engagement and creativity with these daily tasks; other than to read a screen or punch in a number or letter on a keyboard.

I have also heard that watercolor is becoming a "minor art form" in the number of artists and sale price of the work. I'm not an art history buff, but I understand that in the old days the medium of watercolor was used to conceive a piece of art or as a sketching tool, with an oil painting as the final work. The early watercolor pigments were not colorfast and would fade out over time. This thinking continues today to some extent although modern pigments have all but eliminated the problem. The use of glass in a frame to protect the watercolor art is considered as a drawback compared to oil paintings. Today we have clear coat finishes that eliminate the need for glass if desired. All of these factors should level the playing field between watercolor and other medium.

As we all know watercolor is unpredictable and keeps our creativity engaged as the piece takes on its own life, changing as we go. Its range of transparency to opaqueness is unique to the medium. My opinion is that watercolor demands our engagement and creativity and will never become a minor art form.

February Meeting

Suzanne Shaff, "The Cuban Portrait Painting Project: Adapting Heart-Head-Hand to Imperial-Sized Watercolor Painting"

February 10th, 7 pm. A LIVE demo at the Hopkins Center for the Arts, 1111 Mainstreet, Hopkins, MN 55343

There is more to painting on an Imperial-sized sheet of watercolor paper (29.5"x41") than just making everything bigger. It's a qualitatively different painting experience. When I talk to others about the messy, convoluted process of making art I speak in terms of Heart, Head and Hand. The Heart is about inspiration. The Head is about strategy. The Hand is about the making.

During my years as a professional photographer, I discovered the life-changing joy that comes from slowly allowing my innate vision to move out from under all of the external noise and internal doubt. This conscious/unconscious knowledge directed my camera every time I lifted it to my eye. I'd found my personal style.

When I returned to watercolor painting after a 29 year hiatus I had a Heart full of ideas and a well schooled Head overflowing with how-to knowledge. But, I seriously disliked the way my Hand applied the paint to the paper. My proverbial 'slip twixt the cup and the lip' was my Hand.

If I could do with painting what I had done with picture taking, would an authentic watercolor style eventually flow from my Hand? In a surprisingly short time, with the encouragement of my mentor, I was able to quiet all of the 'shoulds' and what-ifs. Astonishingly, the Hand delivered! I was cautiously in awe of what my Hand could do with watercolor paint. Heart, Head and Hand became a working triad. At this point I moved quickly into the Cuban Portrait Painting Project which marked the beginning of my relationship with Imperial-sized watercolor paper.

My presentation will explain how I had to adapt my vision (Heart), my preparation (Head) and my application of paint to paper (Hand) to work with the real estate of a piece of Imperial-sized paper.

You'll explore: the interplay between figurative subject(s) and backgrounds, natural design in reference materials, cropping impact, pigment maintenance, high ratio of pigment to water, intentional and spontaneous marks, use of titanium white, and the freedom to change your mind.

Each day begins with a project-specific demo: unconventional exploration of eyes and faces; single-figure focus with nonspecific background; integrating figurative grouping with background elements, for examples. Artists receive lots of personal attention and plenty of painting time.


